#### Journal of Humanistic Counseling—Call for Editor

The Association for Humanistic Counseling (AHC) is seeking applications from individuals interested in serving as the next editor of the Journal of Humanistic Counseling (JHC). Authors who submit their manuscripts to JHC generally pursue topics related to humanistic counseling and development and research and critical reviews emphasize innovative programs and practices to promote tolerance, nurture diversity, and uphold human rights.

Applications to serve as the next editor of IHC will be evaluated on the following criteria:

- I. One's experience as an editorial board member in one or more peer-reviewed counseling-related journals;
- 2. One's experience as Editor or Associate Editor of a peer-reviewed publication is preferred, especially a journal pertinent to humanistic counseling;
- 3. One's record of scholarly publications in refereed journals, especially focused on humanistic counseling ideology and/or practice;
- 4. One's service to AHC; and
- 5. One's evidence of support from one's academic institution, with examples including but not limited to course releases, graduate assistant support, etc.

Interested individuals should submit the following application materials: (a) statement of vision for the editorial direction for JHC, (b) current curriculum vita, and (c) up to five of the applicant's most significant publications (with particular focus related to humanistic counseling).


